The EOI No. 4482 dated 22.12.2021 invited by 10.01.2022 from interested authorized vendors is here by cancelled on account of unavoidable circumstances. However, in continuation to the said EOI, all the authorized vendors of NCERT willing to procure and distribute NCERT Text Books to all the students of class VI to VIII and all ST /SC students of class IX & X of 314 OAVs located at 314 blocks of the State with tentative budget Rs. 5.56 Cr., are hereby intimated to submit their written offer with processing fees of Rs. 5000/- (Rupees Five Thousand) only along with bid security declaration on or before 31/01/2022, 5:00 P.M.

The sealed envelope containing the application along with required documents super scribed "Application for Procurement & Distribution of NCERT Text Books to 314 OAVs during 2022-23" should reach the undersigned by registered post or speed post only by 31.01.2022, 5:00 P.M. The TOR enclosed may be referred for filling up of the application and other details.

- (iv) Letter in support of empaneled vendorship of NCERT.
- (v) Bid security declaration form.
- (vi) Processing Fees of Rs. 5000/- (Rupees Five Thousand).

Terms Of Reference (Revised)

- (i) The vendor will submit processing fees of Rs. 5000/- (Rupees Five Thousand) only in shape of BD in favour of State Project Director, OAVS payable at Bhubaneswar along with Offer Letter.

- (ii) The vendor quoting the highest rate of discount on the price of the books will be selected. In case of tie of the rate of discount, there will be scope of negotiation for finalizing the rate of discount.
- (iii) The selected vendor will have to deposit performance security @ 3% of the tentative cost of books in shape of BD in favour of State Project Director, OAVS payable at Bhubaneswar.
- (iv) The selected vendor will sign an agreement (as 2nd party) with the State Project Director, OAVS (1st party).
- (v) The agreement will bear the penal provision for deficiency in service of the vendor as per the criteria fixed by the Selection Committee.
- (vi) No advance will be paid by the vendor and the 2nd party will supply the text books at OAV point duly packed in good condition.
- (vii) The vendor has to periodically apprise the State Project Director, OAVS regarding the progress of supplies.
- (viii) Delivery of the books at Vidyalaya point shall be made by the vendor in accordance with the time schedule specified by OAVS and the vendor shall have to bring the acknowledgment with signature of the Principal concerned in the prescribed format before submitting the bills for payment.
- (ix) Further it is to mention that the written offers will be opened on 01 /02 /2022 at 11:00 A.M at the OAVS Conference hall for final selection of the authorized vendor for 2022-23 following due procedure in presence of the committee members and all the authorized representative of vendors.

Hence, all the applicants are hereby informed to remain present at OAVS conference hall at the time & date mentioned above and participate in the meeting.
