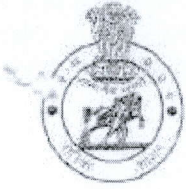
With reference to the subject cited above, it is to intimate that it has been decided in the 5<sup>th</sup> meeting of the Executive Committee of the Odisha Adarsha Vidyalaya Sangathan, for exemption of the examination fee up to class-VIII. The students reading in OAVs are facing four no. of examinations in an academic year. As per practice the question papers are sent to the Principals from the state office through e-mail & the Principals down load the same & make it photo copies as per their requirements. The cost of the photo copies was born out of the contingency fund of the Vidyalayas.

Now it has been decided in the Executive Committee, of OAVS for exemption of the examination fee i.e. two periodic tests, one half yearly & one annual examination of the students reading in class-VI, VII & VIII. The cost @ Rs 40/- per candidate per examination may be met out of the contingency fund of the Vidyalayas.

Therefore Rs 40/- per examination per candidate shall be paid by the students of class IX & X from the annual examination of the academic session 2017-18.


