Simultaneously application is also invited through online mode for Odisha Mining Adarsha Vidyalaya Entrance Test (OMAVET), 2026 for direct admission to Class-VI and for lateral entry to Class-VII, VIII & IX in vacant seats (Category wise) in each Odisha Mining Adarsha Vidyalayas of the State during the academic session 2026-27. The procedure and date line for doing the online registration are furnished below.


